ENCELA WITH CASE NO. 05-09-3109, PRISCO E. ENORME WITH CASE NO. 05-09-856, ALLAN F. BAROTILLO WITH CASE NO. 05-09-2705, NORMA E. DEL ROSARIO WITH CASE NO. 05-09-2573, JUAN E.
