RESOLUTION NO. 58 S - 2019

A RESOLUTION ADOPTING REPUBLIC ACT NO. 10028, "AN ACT EXPANDING THE PROMOTION OF BREAST FEEDING, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7600, OTHERWISE KNOWN AS "AN ACT PROVIDING INCENTIVES TO ALL GOVERNMENT AND PRIVATE HEALTH INSTITUTIONS WITH ROOMING-IN AND BREASTFEEDING PRACTICES AND FOR OTHER PURPOSES".

WHEREAS, the Local Government Unit of Gubat adopts the policy of State, "The State shall likewise protect working women by providing safe and healthful working conditions, taking into account their maternal functions, and such facilities and opportunities that will enhance their welfare and enable them to realize their full potential in the service of the nation";

WHEREAS, there is an urgent need for this local government unit to adopt the implementation of the said Act in order to create a positive environment for working and lactating mother in order to ensure access to comprehensive, current and culturally appropriate lactation care and services for all women including support for breastfeeding mothers in the workplace;

WHEREAS, compliance by this local government to such law is imperative for the protection of working and lactating mothers in this municipality as part of the program for gender advocacy for women and children;


NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramilo S. Fajardo, it was;

RESOLVED, as it is hereby resolved, adopting Republic Act 10028, "An Act Expanding the Promotion of Breastfeeding, Amending for the Purpose Republic Act No. 7600, Otherwise Known as "An Act Providing Incentives to All Government and Private Health Institutions with Rooming-In and Breastfeeding Practices and For Other Purposes";
