RESOLUTION NO. 59 S - 2019

A RESOLUTION ADOPTING REPUBLIC ACT 7600, "AN ACT PROVIDING INCENTIVES TO ALL GOVERNMENT AND PRIVATE HEALTH INSTITUTIONS WITH ROOMING-IN AND BREASTFEEDING PRACTICES AND FOR OTHER PURPOSES.

WHEREAS, the Local Government Unit of Gubat adheres to the policy of the State in encouraging the practice of breastfeeding in the Philippines;

WHEREAS, compliance to the said law by this local government unit will particularly direct us to the rules and regulations which contain the standard procedures to be followed in rooming-in and breastfeeding in all private and government health institutions. The regulations likewise cover the establishment of lactation stations in every private enterprises, government agencies, government-owned and controlled corporations and operation of human milk banks;

WHEREAS, the adoption of this local government unit to the said law will strengthened the implementation of child and maternal health care program of this municipality;

NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramilo S. Fajardo, it was;

RESOLVED, as it is hereby resolved, adopting Republic Act No. 7600, "An Act Providing Incentives to all Government and Private Institutions with Rooming-in and Breastfeeding Practices and for Other Purposes;
