MDC EXECOM RESOLUTION NO. 1 S-2020

A RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN OF GUBAT THE APPROVAL OF THE REPROGRAMMING OF THE SAVINGS FROM THE IMPLEMENTATION OF VARIOUS PROJECTS, THE SAVINGS FROM THE 2019 BUDGET, AND THE ADDITIONAL AMOUNT ALLOCATED TO THE MUNICIPAL DEVELOPMENT FUND FROM THE 2020 INTERNAL REVENUE ALLOTMENT AMOUNTING TO FOUR MILLION FIVE HUNDRED AND SIXTY-TWO THOUSAND AND FOUR HUNDRED EIGHTEEN PESOS AND EIGHTY-EIGHT CENTAVOS (P4,562,418.88) INTO (1) CONSTRUCTION OF MARKET BUILDING IN BARANGAY LUNA-CANDOL (P2,474,977.77), (2) SAFE CLOSURE/REHABILITATION OF DUMPSITE (ADDITIONAL FUND) IN BARANGAY TAGAYTAY (P1,650,907.00), (3) CONSTRUCTION OF IRRIGATION CANAL IN BARANGAY UNION (P110,000.00), (4) IMPROVEMENT OF WATER SYSTEM IN BARANGAY TOGAWE (P250,000.00), AND (5) CONSTRUCTION OF SHALLOW WELL IN BARANGAY BERIRAN (P76,534.11)

WHEREAS, Section 111 of the Local Government Code states that an Executive Committee shall be created to represent and act on behalf of the municipal Development Council particularly on matters requiring immediate action or attention of the Council;

WHEREAS, the Municipal Treasurer and the Municipal Accountant had jointly certified (Annex A) to the availability for reprogramming of Four Million Five Hundred and Sixty-Two Thousand and Four Hundred Eighteen Pesos and Eighty-Eight Centavos (P4,562,418.88) the three sources of which are the following: (1) Savings (P121,534.11) from the implementation of the following projects—1.1 Construction/Improvement of Water System in Barangay Togawe (P6,850.00), 1.2 Construction of Material Recovery Facility in Barangay Manapao (P22,350.00), 1.3 Construction of Shared Service Facility in Barangay Carriedo (P15,043.68), 1.4 Construction of Shared Service Facility in Barangay Luna Candol, (P9,568.84), 1.5 Construction of Shallow Well (Pump with Cover) in Barangay Bagacay (P2,000.00), 1.6 Concrete Paving of Sidewalk, Purok 3, Quezon Street in Barangay Balud del Norte (P6,652.65), 1.7 Rehabilitation of Streetlights in Barangay Paradijon (P20,000.00), 1.8 Rehabilitation of Drainage Canal in Barangay Luna Candol (P21,300.00), 1.9 Construction of Slope Protection in Barangay Union (P17,768.94), (2) the Savings from the 2019 (P4,125,884.77), and (3) Additional Fund for the 20% Municipal Development Fund from the 2020 Internal Revenue Allotment (P315,000.00);

WHEREAS, the Executive Committee of the Municipal Development Council met on February 13, 2020 and agreed to reprogram the aforementioned savings and the additional fund for the 20% Municipal Development Fund from 2020 Internal Revenue Allotment into the

following projects: (1) Construction of Market Building in Barangay Luna-Candol (P2,474,977.77), (2) Safe Closure/Rehabilitation of Dumpsite (Additional Fund) in Barangay Tagaytay (P1,650,907.00), (3) Construction of Irrigation Canal in Barangay Union (P110,000.00), (4) Improvement of Water System in Barangay Togawe (P250,000.00), and (5) Construction of Shallow Well in Barangay Beriran (P76,534.11);


