### RESOLUTION NO. 63 S - 2019

A RESOLUTION STRONGLY SUPPORTS THE IMPLEMENTATION OF REPUBLIC ACT NO. 10410, "AN ACT RECOGNIZING THE AGE FROM ZERO (0) TO EIGHT (8) YEARS AS THE FIRST CRUCIAL STAGE OF EDUCATIONAL DEVELOPMENT AND STRENGTHENING THE EARLY CHILDHOOD CARE AND DEVELOPMENT SYSTEM, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES".

WHEREAS, the Local Government Unit of Gubat adopts the policy of the State to promote the rights of children to survival, development and special protection with full recognition of the nature of childhood and its special needs; and to support parents in their roles as primary care givers and as their children's first teachers. Further, the State recognizes the age from zero (0) to eight (8) years as the first crucial stage of educational development of which the age from zero (0) to four (4) years shall be the responsibility of Early Childhood Care and Development (ECCD) Council. Therefore, the responsibility



to help develop children in the formative years between five (5) to eight (8) years shall be with the Department of Education (DepEd);

WHEREAS, it is deemed appropriate that the implementation of this Act must be strengthened in order for this local government unit to be clearly abreast of the program particularly on the standards in providing accessible environments for children with disabilities and special needs ages zero (0) to eight (8) years old;

NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramilo S. Fajardo, it was;




