RESOLUTION NO. 66 S-2020

A RESOLUTION REQUESTING HON. EDUARDO MANAHAN AÑO, SECRETARY, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THROUGH DIRECTOR LEONARD R. BANAGO, BUREAU OF FIRE PROTECTION (BFP), TO ALLOCATE ONE (1) UNIT OF FIRE TRUCK FOR USE OF THE GUBAT MUNICIPAL FIRE STATION, MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Municipality of Gubat is composed of forty-two (42) barangays having an approximate total population of 60,000, has only one unit of 39-year-old fire truck;

WHEREAS, the Gubat Municipal Fire Station serves not only the Municipality of Gubat but likewise its adjacent municipalities of Prieto Diaz, Barcelona and Bulusan which have no fire station;

WHEREAS, on June 22, 2014, the Gubat Public Market was totally wrecked by fire that caused magnitude of damaged to the local government owned buildings and facilities, and total loss of goods and commodities due to inadequacy of firefighting provisions and capabilities;

WHEREAS, this municipality intensifies its program for the maintenance of public order and safety in view of the necessity to ensure the safety of the general public by effectively implementing the program/projects designed to promote safety and protection of the public service;

WHEREAS, the municipality cognizant and aware of the necessity of having a new and modernized firefighting facility and equipment is financially incapable to acquire such provisions thence, this request;


NOW THEREFORE, on motion of Honorable Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to request Hon. Eduardo Manahan Año, Secretary, Department of Interior and Local Government (DILG) to allocate One (1) unit of fire truck for use of the Gubat Municipal Fire Station, Municipality of Gubat, Province of Sorsogon;

RESOLVED FURTHER, that copies of this resolution be furnished Hon. Eduardo Manahan Año, Secretary, Department of Interior and Local Government (DILG), DILG-NAPOLCOM Center, EDSA corner Quezon Avenue, Quezon City, Philippines 1100; Director Leonard R. Banago, 7th Floor BFP National Headquarters Building, Agham Road, Barangay Bagong Pag-asa, Diliman, Quezon City, for favorable and appropriate action and others concerned for information and guidance.
