RESOLUTION NO. 68 S - 2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, LOCAL GOVERNMENT UNIT OF GUBAT, PROVINCE OF SORSOGON, TO FILE CASE FOR EJECTMENT OR RECOVERY OF POSSESSION OF A REAL PROPERTY OWNED BY THE MUNICIPALITY SITUATED AT MUNICIPAL COMPOUND, BARANGAY PINONTINGAN, GUBAT, SORSOGON, AGAINST THE DIGITEL MOBILE PHILIPPINES, INCORPORATED AND/OR THE PHILIPPINE LONG DISTANCE TELEPHONE INCORPORATED (PLDT Inc.).

WHEREAS, the local government unit of Gubat owns a parcel of land where a building of Digitel Mobile Philippines, Inc. is erected;

WHEREAS, the said building was long time abandoned and the municipality needs the land to be used for public purposes;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, Local Government Unit of Gubat, Province of Sorsogon, to file a case for Ejectment or Recovery of Possession of a Real Property owned by the Municipality situated at Municipal Compound, Barangay Pinontingan, Gubat, Sorsogon, against the Digitel Mobile Philippines, Incorporated and/or the Philippine Long Distance Telephone Incorporated (PLDT Inc.).


RESOLVED FURTHER, that Hon. Sharon Rose G. Escoto, Municipal Mayor is hereby given full power and authority to act for and in behalf of the municipality and to perform the following acts:

1. To represent the local government unit of Gubat, Province of Sorsogon in order to file a case for Ejectment and/or Recovery of Possession against Digitel Mobile Philippines, Inc. and/or PLDT, Inc., relative to the property owned by the LGU of Gubat located at Municipal Compound, Barangay Pinontingan, Gubat, Sorsogon where a building constructed by the Digitel Mobile Philippines, Inc. and/or PLDT, Inc. can be found and to present any and all evidence;
2. To sign and execute proper complaint, petition, affidavit including Verification and Certification of Non-Forum Shopping related to the filing of every pleading, petition, memorandum, motion or position paper before any court of law or government agencies, as well as to sign and interpose appeal, petition for certiorari or appeal memorandum wherever necessary;
3. To appear in any conciliation/mediation/arbitration proceedings relative to the above;
4. To enter into compromise agreement and/or amicable settlement in the name and stead of the local government unit, attend pre-trial conference and perform all the provisions mandated under Rule 18 of the 1997 Rules of Civil Procedures, in connection with and related to the aforesaid action/s to be filed against the Digitel Mobile Philippines, Inc. and/or PLDT, Inc. concerning the same subject matter, and;
5. To sign, execute, receive and/or deliver contracts and agreements, other papers and/or money to effect with his power in this authorization pertinent to the above described authority.
6. To disburse and/or release local funds sourced out from any available appropriations for the expenses in relation to the purpose from which this power and authority is given.

RESOLVED FURTHERMORE, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, and any other offices concerned for their information and guidance.
