A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) - MINES AND GEOSCIENCES BUREAU (MGB), REGIONAL OFFICE NO. V, REGARDING THE CONDUCT OF GEOHAZARD IDENTIFICATION SURVEY OF GUBAT RESETTLEMENT AREA IN BRGY. SAN IGNACIO, GUBAT, SORSOGON.

WHEREAS, this local government unit in partnership with the Department of Environment and Natural Resources (DENR) - Mines and Geosciences Bureau (MGB), Regional Office No. V, will conduct geohazards identification and assessment survey of Gubat Resettlement Area at Brgy. San Ignacio, Gubat, Sorsogon, to determine and ensure that the area is not susceptible or vulnerable to various geologic hazards and natural



dangers such as floods, landslides and ground subsidence; and in order to have potential information as to the safety of the ground before the full implementation of the resettlement program;

WHEREAS, the above undertaking will require this Local Government Unit to enter into Memorandum of Agreement (MOA) with the DENR – Mines and Geosciences Bureau (MGB), Regional Office V, covering the terms and conditions in the conduct of geohazards identification survey;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Ramilo S. Fajardo, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G.
