ROQUE, DIRECTOR FOR LOGISTICS, CAMP CRAME, QUEZON CITY FOR ONE (1) UNIT PATROL CAR FOR USE OF THE PHILIPPINE NATIONAL POLICE - GUBAT MUNICIPAL POLICE STATION, GUBAT, SORSOGON.

WHEREAS, the Municipality of Gubat comprises of 42 barangays and more or less 61,000 individual populace, has only one (1) unit serviceable Patrol Car being used for patrolling around the municipality;

WHEREAS, to facilitate the task of the PNP in minimizing, if not eradicating crimes including illegal drugs, illegal gambling and other petty crimes and likewise in responding to emergency cases during disasters, an additional patrol car in this municipality is very necessary;

WHEREAS, the mobility of the police personnel requires vehicles thus, additional patrol car is imperative in maintaining the local peace and order in the entire municipality;

NOW, THEREFORE, on motion of Honorable Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to request Police General Archie Francisco F. Gamboa, Chief, Philippine National Police, Thru Police Major General Edwin C. Roque, Director For Logistics, Camp Crame, Quezon City for One (1) Unit Patrol Car for use of the Philippine National Police - Gubat Municipal Police Station, Gubat, Sorsogon;
