RESOLUTION NO. 73, S-2020

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) ON THE UTILIZATION OF GUFADeco WAREHOUSE AS PALAY BUYING STATION.

WHEREAS, the Local Government Unit of Gubat will allow the National Food Authority, through its Provincial Office, to make use of the GUDADECO Warehouse located at Highway 59, Gubat, Sorsogon as their Palay Buying Station and storage for grains;

WHEREAS, terms and conditions relative to the utilization of the said GUFADeco Warehouse were embodied in a Memorandum of Agreement (MOA) and will be mutually agreed upon by the parties herein prior to its occupancy;

WHEREAS, this endeavor is necessary to immediately facilitate the implementation of palay procurement by the National Food Authority to provide better assistance and services to the farmers of this municipality especially that harvest season is about to start this month;

NOW THEREFORE, on motion of Honorable Kenneth D. Escandor and duly seconded by Honorable Alvin E. Rosales, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the National Food Authority (NFA) on the utilization of GUFADeco Warehouse as Palay Buying Station;
