

FRESNOZA WITH CASE NUMBER 05-09-3183, PIO M. ENCINARES WITH CASE NUMBER 05-09-1186, MA. LUZVIMINDA M. ESPEDIDO WITH CASE NUMBER 05-09-2704, ALMA F. ESCARTIN WITH CASE NUMBER 05-09-2871, EDUARDO VILLAROYA WITH CASE NUMBER 05-09-771, RAYMUND E. ESCALORA WITH CASE NUMBER 05-09-2363, HILARIO E.
