RESOLUTION NO. 08 S-2019

A RESOLUTION EXTENDING THE TIME OF PAYMENT FOR LOCAL TAXES, FEES AND CHARGES WITHOUT SURCHARGES OR PENALTIES, IN THE MUNICIPALITY OF GUBAT, SORSOGON, TO FEBRUARY 28, 2019.

WHEREAS, as embodied in Section 167 of the Local Government Code of 1991, "All taxes, fees and charges shall be paid within the first twenty (20) days of January or each subsequent quarter as the case maybe;"

WHEREAS, Section 167 of R.A. 7160 likewise empowers the Sangguniang Bayan to "extend the time for payment of such taxes or charges without surcharges or penalties, but only for a period not exceeding six (6) months;"

WHEREAS, there is a necessity to provide said extension of payment in consideration of the negative impact to our business sectors of the country's high inflation rate and the partial destruction of our Gubat Public Market due to fire sometimes in June 2014 which up to this date significantly affects their sales and income;


