RESOLUTION NO. 80 S - 2020

A RESOLUTION TO AUTHORIZE HONORABLE SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE COMMISSION ON HIGHER EDUCATION (CHED) AND THE BICOL UNIVERSITY REGARDING THE USE OF THE BICOL UNIVERSITY FACILITY AT BARANGAY BUENAVISTA, GUBAT, SORSOGON AS QUARANTINE CENTER/COMMUNITY ISOLATION UNITS FOR CORONA VIRUS DISEASE 2019 (COVID 19) PANDEMIC.

WHEREAS, the Philippines is one of the countries affected by the Corona Virus Disease 2019 (COVID 19) that claims hundreds of Filipinos infected, tens of deaths and many more in danger of infection, as declared by the World Health Organization (WHO) as pandemic;

WHEREAS, on 16 March, 2020 President Rodrigo Roa Duterte issued Proclamation No. 929 declared a State of Calamity reiterating the call for government agencies to mobilize necessary resources to curtail and eliminate the COVID 19 threat;

WHEREAS, the Department of the Interior and Local Government (DILG) in compliance with the Presidential Directive issued Memorandum Circular No. 2020 – 062 directing all LGUs to fully implement the Enhanced Community Quarantine for the Island of Luzon and further created the Inter-agency for the Management of Emerging Infectious Diseases in the Philippines which set a policy for the LGUs to establish quarantine centers/community isolation units (CIUs) using facilities of state universities and colleges by way of entering MOAs;

NOW, THEREFORE, on motion of Honorable Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to authorize Honorable Sharon Rose G. Escoto, Municipal Mayor to enter into a Tripartite MOA with the Commission on Higher Education (CHED) and the Bicol University for the use of Bicol University Facility at Barangay Buenavista, Gubat, Sorsogon as Quarantine Center/Community Isolation Units for Corona Virus Disease 2019 (COVID19) Pandemic;

RESOLVED FURTHER, that copies of this resolution be furnished Honorable Sharon Rose G. Escoto, Municipal Mayor, Gubat, Sorsogon, for her appropriate action; Chairman Prospero J. De Vera III, CHED, HEDC Building, C.P. Garcia Avenue, U.P. Diliman, Quezon City; Dr. Arnulfo M. Mascarinas, SUC President, Legazpi City, Albay and others concerned for their information and guidance.
