RESOLUTION NO. 81 S - 2020

A RESOLUTION EARNESTLY REQUESTING MR. RAMON S. ANG, CHAIRMAN, SAN MIGUEL CORPORATION THRU MR. FRANCISCO S. ALEJO III, CHIEF OPERATING OFFICER, FOR FOOD PACKS TO BE DISTRIBUTED TO HOUSEHOLDS IN THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON AFFECTED BY THE ENHANCED COMMUNITY QUARANTINE AMID THE CORONA VIRUS DISEASE 2019 (COVID 19) THREAT.

WHEREAS, in the light of the pronouncement of the World Health Organization (WHO) stating Corona Virus Disease 2019 (COVID 19) as Pandemic, the national government through Presidential Proclamation No, 929, declared a state of calamity and further calling all government agencies to mobilize necessary resources to curtail and eliminate the COVID 19 threat;

WHEREAS, in compliance to the presidential directive, the local government unit of Gubat, Sorsogon had utilized portion of its 5% Calamity Fund and reprogrammed several development projects to augment funds for disaster preparedness and response efforts to curtail the spread of COVID 19, and continue to provide basic services to the affected population;

WHEREAS, considering that the state of calamity is covers for a period of six (6) months and the Enhanced Community Quarantine (ECQ) and Social Distancing covers for an initial period of one (1) month, local funds may not be enough to provide adequate basic services, thus, assistance from private entities and individuals are sourced out;

NOW, THEREFORE, on motion of Honorable Valentin A. Pura IV and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to earnestly request Mr. Ramon S. Ang, Chairman, San Miguel Corporation thru Mr. Francisco S. Alejo Iii, Chief Operating Officer, for food packs to be distributed to households in the Municipality of Gubat, Province of Sorsogon affected by the enhanced community quarantine amid the Corona Virus Disease 2019 (COVID 19) threat.


