RESOLUTION NO. 82 S - 2020

A RESOLUTION TO AUTHORIZE HONORABLE SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL FIELD OFFICE NO. V CONCERNING THE AVAILMENT AND IMPLEMENTATION OF THE SOCIAL AMELIORATION PROGRAM (SAP) OF THE NATIONAL GOVERNMENT.

WHEREAS, on 12 March, 2020, the Inter-agency Task Force on Emerging Infectious Diseases (IATF-EID) raised the COVID 19 threat to the highest alert, with this, the entire Luzon was placed under enhanced community quarantine;

WHEREAS, the imposition of community quarantine and social distancing measures restrain and controls movement thus, affected the means of livelihood and subsistence of low income households;

WHEREAS, with the passage of Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act of 2020" the national government through the DSWD will provide emergency subsidy to low income households that will be in the form of social amelioration programs (SAP);

WHEREAS, to ensure the expeditious delivery of this assistance, the DSWD and the LGU of Gubat, Sorsogon resolved to enter into a MOA hence this resolution;


NOW, THEREFORE, on motion of Honorable Alvin E. Rosales and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to authorize Honorable Sharon Rose G. Escoto, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Regional Field Office No. V concerning the availment and implementation of the social amelioration program (SAP) of the national government;


