

RESOLUTION NO. 83 S-2019

A RESOLUTION AUTHORIZING THE GRANT OF MONTHLY ALLOWANCE IN THE AMOUNT OF FIVE THOUSAND (P5,000.00) PESOS TO QUALIFIED OFFICERS OF NATIONAL GOVERNMENT AGENCIES ASSIGNED IN THE MUNICIPALITY OF GUBAT, EFFECTIVE FROM THE DATE OF THEIR ASSUMPTION.

WHEREAS, Section 447 (a) (1) of the Local Government Code of 1991 states that "when the finances of the municipality allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers and other government officials stationed in or assigned to the municipality";

WHEREAS, Department of Budget and Management (BDM) Compensation Policy Guidelines dated March 23, 1998, provides that, national government officials may collect additional compensation in the form of honorarium from the local government unit where they are assigned, as provided under Section 5.0 of LBC 62;



NOW, THEREFORE, on motion of Honorable Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to grant monthly allowance in the amount of Five Thousand (P5,000.00) Pesos to Officers of National Government Agencies assigned in the Municipality of Gubat, effective from the date of their assumption


RESOLVED FURTHER, that the following officers of NGA's are entitled and qualified to receive allowance from the local government, to wit:
