RESOLUTION NO. 84 S - 2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO FILE A PETITION FOR EXCEPTION BEFORE THE COMMISSION ON ELECTIONS (COMELEC) IN RELATION TO THE RELEASE OF PUBLIC FUNDS INTENDED FOR THE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS) BY THE LOCAL GOVERNMENT UNIT OF GUBAT, PROVINCE OF SORSOGON.

WHEREAS, the Commission on Elections issued COMELEC Resolution No. 10511 providing the Rules and Regulations Governing Ban on Public Works and Release, Disbursement and Expenditures of Public Funds, xxxxx in connection with the in connection with the May 13, 2019 Automated Synchronized National and Local Elections;

WHEREAS, Section 1 hereof, provides that, Effective March 29, 2019 until May 12, 2019, no public official or employee, xxxxx shall release, disburse or expend funds for: (2) "The Department of Social Welfare and Development and any other office in other department of government performing functions similar to said department, except for salaries of personnel, and for such other routine and normal expenses, and for such other expenses as the Commission may authorize, xxxxx";

WHEREAS, Section 8 of the same resolution further provides that, Social Welfare Projects and Service are not covered by the ban. However, the requesting party shall file a Petition for Exception before the Clerk of the Commission;

WHEREAS, the disbursement and release of AICS intended for assistance for burial, healthcare and calamity to indigents is of great necessity, thence, this request;

NOW, THEREFORE, on motion of Hon. Aiza E. Encinares and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to File a Petition for Exception before the Commission on Elections – (COMELEC) in relation to the release of public funds intended for the Assistance to Individuals in Crisis Situation (AICS) by the Local Government Unit of Gubat, Province of Sorsogon;

RESOLVED FURTHER, that copies of this resolution be furnished Hon. Sheriff M. Abas, Chairman, COMELEC, Intramuros, Manila; Hon. Sharon Rose G. Escoto, Municipal Mayor, Gubat, Sorsogon and other offices concerned for their information and guidance.
