A RESOLUTION APPEALING TO THE SANGGUNIANG PANLALAWIGAN TO RECONSIDER ITS REVIEW ACTION ON APPROPRIATION ORDINANCE NO. 2019-01 OF THE MUNICIPALITY OF GUBAT, SORSOGON AS PER SANGGUNINAG PANLALAWIGAN RESOLUTION NO. 90-2019.

WHEREAS, the Sangguniang Bayan of Gubat has received copy of Sangguniang Panlalawigan Resolution No. 90-2019 dated Mach 18, 2019, Declaring Appropriation Ordinance No. 2019-01 of the Municipality of Gubat, Sorsogon Operative in its Entirety Subject to Some Conditions, copy of which is hereto attached as Annex "A";

WHEREAS, one of the conditions stated in the said resolution under par. 2, item no. 1, to wit; "1. The creation and funding of new positions is hereby disallowed considering that the municipality has already exceeded the PS CAP Limitation as mandated under Section 325 (a) of R.A. 7160", copy of which is hereto attached as Annex "A – 1";

WHEREAS, the new positions contemplated in the above condition is the two (2) Local Legislative Staff Employee I under the Office of Sangguniang Bayan-Secretariat and Office of the Vice Mayor created under Municipal Ordinance No. 2019-002 which was favorably reviewed and declared to be valid by the Sangguniang Panlalawigan by virtue of SP Resolution No. 60-2019 dated February 18, 2019, copy of which is hereto attached as Annex "B";

WHEREAS, consistent with the above Municipal Ordinance No. 2019-002 creating said positions, the appropriations of funds thereof by this local government unit under Appropriation Ordinance No. 2019-01 is accordingly mandatory and proper, thus, disallowance of the same is found inconsistent;


WHEREAS, this Sangguniang Bayan further calls for reconsideration in disallowing the creation and funding of new positions for the following justifications to wit:

- 1. Municipal Ordinance No. 2019-002, creating the said positions was already approved by this Honorable Board as per Sangguniang Panlalawigan Resolution No. 60-2019 dated February 18, 2019, declaring said Ordinance valid, herein attached as Annex "B";
- 2. The Office of the Vice Mayor of Gubat, Sorsogon has only two (2) existing personnel occupying the plantilla position of Driver I and Utility Worker (Admin. Aide I), the need for a new position who will perform clerical task is of urgency and necessity, *copy of which is hereto attached as Annex "C"*;
- 3. That the bulk of the work load at the Office of this Sangguniang Bayan is mainly lodged to the Secretariat, thus, there is a need for additional staff to augment its work force in the exigency of public service;
- 4. The creation and funding of this new positions does not and will not in anyway affect and/or defeat the implementation of programs, projects and activities of this local government unit neither this will diminish the efficiency in the delivery of basic services to the public considering that this municipality is financially able to appropriate funds for its salary requirements and other personal services expenditures;

WHEREAS, this reconsideration is being sought by this Sanggunian in the furtherance of its commitment to provide a more equipped and functional legislative organization, all for the interest of proper legislation and public service;

NOW THEREFORE, on motion of Honorable Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to appeal to the Sangguniang Panlalawigan to reconsider its review action on Appropriation Ordinance No. 2019-01 of the Municipality of Gubat, Sorsogon as per Sangguniang Panlalawigan Resolution No. 90-2019;

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2019-01 OF THE MUNICIPALITY OF GUBAT, SORSOGON OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 2019-01, of the Municipality of Gubat, Sorsogon authorizing its Supplemental Budget No. 1 for CY-2019 involving an appropriation of SIX MILLION FOUR HUNDRED TWENTY THOUSAND THREE HUNDRED SIXTY-TWO and 64/100 (P6,420,362.64) was submitted for review on March 5, 2019 pursuant to the provision of Republic Act 7160.

WHEREAS, the subject appropriation ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations subject to the following conditions:

- 1. The creation and funding of new positions is hereby disallowed considering that the municipality has already exceeded the PS CAP Limitation as mandated under Section 325(a) of R.A. 7160.
- 2. The utilization and implementation of the appropriated amount for the 4th Tranche Compensation Adjustment Salary Increase shall be in accordance with LBC No.118 dated Jan. 15, 2019 particularly Section 13.1 thereof.
- 3. The grant of Hazard Pay to Public Health Workers shall be in accordance with the provisions stipulated under DBM-DOH Joint Circular No. 1, s- 2016, dated July 15, 2016.
- 4. The appropriation for Donations, Subsidies, Other Expenses particularly those intended for assistance to different programs and activities and the like should

strictly adhere to the provisions of Section 305(b) and 335 of R.A. 7160, which prohibits the use of public funds for religious and private purposes.

- 5. The appropriations for PhilHealth, Pag-lbig, GSIS and other mandatory contributions shall be sufficiently provided as prescribed by Law.
- 6. The use of savings should not prejudice its original intent nor jeopardize valid claimant, if ever there is any.
- 7. The disbursement of all appropriations herein authorized should be subject to the usual accounting and auditing rules and regulations.

NOW, THEREFORE, on motion of Hon. Maria Teresa G. Fragata, duly seconded by Hon. Marnellie B. Robles, the Board RESOLVED, as it is hereby DONE, to declare APPROPRIATION ORDINANCE NO. 2019-1 OF THE MUNICIPALITY OF GUBAT, SORSOGON OPERATIVE IN ITS ENTIRETY, effective as of the fixed date in its enabling ordinance, subject to the posting requirements under Section 59 of RA 7160 and subject, however, to the conditions stated above.

RESOLVED FURTHER, to require the Municipality to comply with the herein conditions and notify this body of actions taken thereon;

RESOLVED FINALLY, to inform the Municipality that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.
