NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Danilo E. Enaje, it was;


RESOLVED, as it is hereby resolved to declare the dropping of Motorized Tricycle Operator's Permit (MTO) in the municipality of the above named applicant;
