NOW THEREFORE, on motion of Honorable Alvin E. Rosales and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to transfer all completed projects implemented which were already under the custody and control of the different end-users/beneficiaries;

RESOLVED FURTHER, that necessary preparation of the required Invoice and Receipt - General Form 30-A by the concerned offices of this local government unit be undertaken to support its transfer;

RESOLVED FURTHERMORE, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, LGU-Gubat, Sorsogon, and any other offices concerned, for their information and guidance.
