A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT OF FERNANDO E. GABUYO WITH CASE NUMBER 05-09-2331 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF APRIL 2019.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the above-named applicant applied before this office for the suspension of their MTOP for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable:

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting April, 2019;
