V, WITH REGARDS TO THE AUGMENTATION OF AID TO INDIVIDUAL IN CRISIS SITUATION (AICS) IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, Aid to Individual in Crisis Situation (AICS) refers to a national social services program which focuses on financial assistance in times of individual crises of the inhabitants especially those who belongs to underprivileged families/inhabitants of this municipality;

WHEREAS, this the Local Government Unit of Gubat will enter into Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) relative to the augmentation of funds of AICS to provide range of services to beneficiaries in accordance with the parameters set by the DSWD Memorandum Circular No. 11 Series of 2019, and as stipulated in RA 11469 otherwise known as "Bayanihan to Heal as One Act" as well as Joint Memorandum Circular No. 1 Series of 2020 wherein the national government shall provide emergency subsidy to families in crisis;

WHEREAS, under said Memorandum of Agreement (MOA), the DSWD shall transfer fund to this local government in the amount of TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) to fast track the distribution of cash assistance to the individuals affected due to the Enhanced Community Quarantine and shall be disposed of by this LGU to qualified clients in accordance with applicable DSWD guidelines and rules;


NOW THEREFORE, on motion of Honorable Danilo E. Enaje and unanimously seconded, it was;
