WHEREAS, the Okada Foundation is a private non-partisan foundation represented by Mr. Kenji Sugiyama with office address at Okada Manila, New Seaside Drive, Entertainment City, Paranaque City, MM;

WHEREAS, the foundation, part of its benevolence and generosity, commits itself to donate Two Hundred Fifty Thousand (P250,000.00) Pesos to local government units affected by the COVID 19 pandemic;
