### RESOLUTION NO. 98 S-2020

A RESOLUTION TO GRANT MORATORIUM TO ALL SPACE/STALLHOLDERS IN THE GUBAT PUBLIC MARKET FROM PAYING RENTALS DURING THE CORONA VIRUS 2019 (COVID 19) PANDEMIC.

WHEREAS, on March 17, 2020, the entire island of Luzon was placed under Enhanced Community Quarantine (ECQ) as per Presidential Proclamation No. 929, declaring the country under State of National Calamity due to Coronavirus Disease 2019 (COVID-19);

WHEREAS, as per Memorandum from the Executive Secretary providing Guidelines in the Management of Coronavirus Disease 2019 (COVID-19) Situation, business/commercial enterprises included in the delivery of essential and basic services were ordered to continue their operation for the duration of the Enhance Community Quarantine (ECQ);

WHEREAS, the Local Government Unit of Gubat in compliance with the above guidelines likewise ensure that the operation and services of essential business/enterprises and establishments within the entire municipality are unhampered, thus, such business establishments were allowed operation subject to IATF protocol on the observance of social distancing and other health standard measures;

WHEREAS, despite operation of these essential business establishments, the limited movement of people and services still contributed to the displacement of income and livelihood to this sectors, thus, this Sangguniang Bayan, by unanimity, provide relief by granting moratorium in the payment of space/stall rentals during the Corona Virus 2019 (COVID 19) pandemic;

WHEREAS, such moratorium for rental shall likewise applies to the stallholders of the newly opened C-Shaped Building whether it is still closed or already on business operation prior to the COVID 19 pandemic;

NOW THEREFORE, on motion of Honorable Valentin A. Pura IV and unanimously seconded, it was;


