RESOLUTION NO. 99 S-2020

A RESOLUTION WAIVING COLLECTION OF SPACE/STALL RENTALS OF LEASES AT THE GUBAT PUBLIC MARKET THAT WHOSE BUSINESS OPERATIONS ARE MANDATORILY CLOSED DURING THE CORONA VIRUS 2019 (COVID 19) PANDEMIC.

WHEREAS, on March 17, 2020, the entire island of Luzon was placed under Enhanced Community Quarantine (ECQ) as per Presidential Proclamation No. 929, declaring the country under State of National Calamity due to Coronavirus Disease 2019 (COVID-19);

WHEREAS, likewise as per Memorandum from the Executive Secretary providing Guidelines in the Management of Coronavirus Disease 2019 (COVID-19) Situation, business/commercial enterprises included and/or categorized as non-essential were ordered to ceased operation for the duration of the Enhance Community Quarantine (ECQ);

WHEREAS, the Local Government Unit of Gubat in compliance with the above guidelines implemented the mandatory closure of non-essential business/enterprises within the entire municipality including business establishments located at the new and old market building owned by the municipality;

WHEREAS, in order to help these business establishments that were worst hit by the effect of Corona Virus 2019 (COVID 19) Pandemic, this Sangguniang Bayan, by unanimity, provides relief by waiving the payment of their respective space/stall rentals;

NOW THEREFORE, on motion of Honorable Valentin A. Pura IV and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to waive collection of space/stall rentals of leasee at the Gubat Public Market that whose business operations are mandatorily closed during the Corona Virus 2019 (COVID 19) pandemic;

RESOLVED FURTHER, that copy of this resolution be furnished Honorable Sharon Rose G. Escoto, Municipal Mayor, for her favourable and appropriate action.
