### REVENUE ORDINANCE NO. 2018- 001

AN ORDINANCE IMPOSING FEES AND CHARGES FOR DROPPING, APPLICATION FOR MTOP AND CHANGE MOTOR/SUBSTITUTION OF UNIT AND SUSPENSION OF OPERATION OF TRICYCLE FOR HIRE IN THE MUNICIPALITY OF GUBAT, SORSOGON.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1 Imposition of Fees and Charges. There shall be collected a fee for the application for dropping, suspension of Municipal Tricycle Operators Permit (MTOP) and substitution of units as described below:

Dropping of MTOP	-	P 500.00
Application for MTOP	-	P1,000.00
Change Motor/Substitution of Unit	-	P 200.00
Suspension of Operation	-	P 100.00

Section 2. Issuance of Official Receipts. The fees and charges shall be payable at the Municipal Treasurer's Office which shall issue official receipt of the payment, such receipt shall form part of the requirements for the issuance of resolution by the Sangguniang Bayan approving the request for dropping and suspension of MTOP, and substitution of units.

Section 3. Effectivity. This ordinance shall take effect immediately after it is publication in a newspaper of general circulation in the Province of Sorsogon.
