AN ORDINANCE IMPOSING FEES AND CHARGES FOR THE USE OF THE FUNCTION HALL OF THE MUNICIPAL PUBLIC LIBRARY BUILDING AND OTHER EQUIPMENT AND FACILITIES THEREIN, Hon. Kenneth D. Escandor, Author

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. It is hereby adopted that the Municipal Public Library Building including its function hall and other facilities is part of the properties declared in the name of the Municipality of Gubat, Sorsogon. Thus, its management and operation are vested within the authority of this local government unit.

<u>Section 2. Imposition of Rentals</u>. There shall be collected the following rates as rental for the use and occupancy of the function hall of the Municipal Public Library Building including its equipment and facilities as described below:

Hall Rental

- P350.00 per hour/inclusive of lights and electric

fan (rental of table and chairs are excluded)

Table Rental

P 40.00 per piece

Chairs Rental

P 10.00 per piece

Sound System

P350.00 per hour

Section 3. Uses of the Function Hall and its Facilities. The property shall be used for a fee as venue for meetings, seminars, conventions and/or any other similar events whether the same are sponsored and/or conducted by public and private entity. However, no fees and charges imposed for the use of the function hall and facilities for the seminars and events sponsored/conducted by the Local Government Unit of Gubat.

The use of function hall and its facilities as venue for birthdays, wedding receptions, baptism, reunions and similar events shall be allowed only during Saturdays and Sundays.

Section 4. Issuance of Receipts. The fees and charges shall be payable at the Municipal Treasurer's Office which shall issue official receipt of the payment, no occupancy of the function hall and use of its equipment and facilities without presenting such receipt of payment.

Section 5. Fees and Charges for Loss/Damaged of Properties. There shall be collected fees and charges for the loss and/or damaged that may be caused to the Municipal Public Library Building or properties therein at an amount equivalent to the prevailing cost of repair and/or prevailing cost of the damaged/lost property and shall be settled within ten (10) days from occurrence thereof.

Section 6. <u>Effectivity</u>. This ordinance shall take effect immediately after publication for at least Three (3) times in a newspaper of general circulation in the Province of Sorsogon.
