A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), REGION V, WITH REGARDS TO THE IMPLEMENTATION OF FISHERFOLK LIVELIHOOD PROJECTS ON SOFT-SHELLED CRAB PRODUCTION AND CRAB FATTENING

WHEREAS, the Local Government Unit of Gubat undertakes to have partnership with the Bureau of Fisheries and Aquatic Resources (BFAR) in the implementation of policies under the National Crab Production and Livelihood Program (NCPLP) through the establishment of Fisher folk Livelihood Projects on Soft-shelled Crab Production and Crab Fattening in the municipality;

WHEREAS, the program contemplated under the Memorandum of Agreement (MOA) will help augment the livelihood of the fisher folks and promote sustainable fisheries projects as a means to strengthen food security program of the municipality;
