A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIDA), REGION V, REGARDING THE IMPLEMENTATION OF PROGRAMS/PROJECTS FOR THE REHABILITATION OF ABACA INDUSTRY IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, this local government unit consider it significant to rehabilitate abaca areas in the municipality due to its very low production levels;

WHEREAS, the Municipality of Gubat undertakes to engage in partnership with the Philippine Fiber Industry Development Authority (PhilFIDA) in the rehabilitation and revival of abaca industry in the municipality;

WHEREAS, the Local Government Unit of Gubat is willing to provide fund for this endeavor considering that abaca industry is foremost one of the potential sources of livelihood;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Cesar D. Esperida, Jr., it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Philippine Fiber Development Authority (PhilFIDA) regarding the implementation of programs/projects for the rehabilitation of abaca industry in the Municipality of Gubat, Sorsogon;
