A RESOLUTION EARNESTLY REQUESTING HON. ERINEO S. MALIKSI, CHAIRMAN, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO), FOR TWO (2) UNITS OF AMBULANCE UNDER THE AMBULANCE DONATION PROGRAM AND AUTHORIZING THE HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO A CONTRACT OF DONATION.

WHEREAS, it is a mandatory duty of the State to protect and promote the right to health of every Filipino by making accessible quality and adequate health care to everybody, especially the poor and the disadvantage;

WHEREAS, the Municipality of Gubat, consisting of Forty Two (42) barangays, has only one (1) unit of old ambulance although serviceable, but unfortunately it is not enough to render adequate service to the people of Gubat especially those who are poor that cannot afford the high cost of transportation at the same time the hospitalization;

WHEREAS, to cater health services particularly those in emergency cases, the service vehicle like ambulance is very necessary in transporting patients for the immediate medication;

WHEREAS, it is significant to authorize the local chief executive to enter into contract of donation as a requirement for the herein request for two (2) units of ambulance for use of the Municipality of Gubat, Sorsogon;

NOW THEREFORE, on motion of Hon. Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to request Hon. Erineo S. Maliksi, Chairman, Philippine Charity Sweepstakes Office (PCSO) for two (2) units of ambulance under the Ambulance Donation Program and authorizing the Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into A Contract of Donation;
