A RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH THROUGH DR. NAPOLEON L. AREVALO, MD, MPH, OIC - DIRECTOR IV, REGIONAL HEALTH OFFICE V, TO ASSIGN TWO (2) PHYSICIANS UNDER THE DOH DOCTOR TO THE BARRIO PROGRAM IN THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON.

WHEREAS, the total population of the Municipality of gubat as of 2015 is 57,195 and there is only one physician in the Rural Health Unit in the person of Dr. Anthony S. Lelis, the Municipal Health Officer (MHO);

WHEREAS, the standard ratio of physician to population in the LGU Health Scorecard is 1:20,000;

WHEREAS, the delivery of quality health services to our constituents is hampered due to lack of physician;

NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, to request the Department of Health through Dr. Napoleon L. Arevalo, MD, MPH, OIC - Director IV, Regional Health Office V, to assign two (2) physicians under the DOH Doctor to the Barrio Program in the Municipality of Gubat, Province of Sorsogon;

RESOLVED FURTHER, that copies of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, Dr. Napoleon L. Arevalo, MD, MPH, the Provincial DOH Officer, Dr. Myrna J.
