RESOLUTION NO. 129 S-2017

A RESOLUTION DESIGNATING HON. SHARON ROSE G. ESCOTO, MR. REYMUNDO F. QUINONES, MR. TOLENTINO FLORESCA AND MS. MARIA TERESA L. JASARENO (REPLACING MR. FLORENDO G. BELEN, JR.) AS SIGNATORIES TO THE LANDBANK OF THE PHILIPPINES (LBP), SORSOGON BRANCH, TRUST FUND ACCOUNT FOR BOTTOM-UP BUDGETING (BUB) – DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) SUSTAINABLE LIVELIHOOD PROGRAM (SLP) OF THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Local Government Unit of Gubat, Sorsogon is maintaining a Trust Fund Account at the Landbank of the Philippines, Sorsogon Branch, under Trust Fund Account No. 000-782-1137-55 intended for the implementation of Bottom-Up Budgeting (BUB) – Department of Social Welfare and Development (DSWD) Sustainable Livelihood Program (SLP);

WHEREAS, there is an urgent need to designate a new signatory on the above Trust Fund Account due to the resignation of Mr. Florendo G. Belen, Jr. from his job as Provincial Coordinator/Project Development Officer II for the Sustainable Livelihood Program of the Department of Social Welfare and Development (DSWD) assigned in the Province of Sorsogon;

WHEREAS, the Local Poverty Reduction Action Team (LPRAT) after deliberation on June 20, 2017 through LPRAT Resolution No. 3 S-2017 designated Maria Teresa L. Jasareno as the new signatory for said trust fund account replacing Mr. Florendo G. Belen, Jr., to facilitate the immediate implementation of Sustainable Livelihood Program (SLP) in the municipality;

Belen, Jr.) as signatories to the Landbank of the Philippines (LBP), Sorsogon Branch, Trust Fund Account for Bottom-Up Budgeting (BUB) – Department of Social Welfare and Development (DSWD) Sustainable Livelihood Program (SLP) of the Municipality of Gubat, Sorsogon.;
