RESOLUTION NO. 130 S-2016

A RESOLUTION EARNESTLY REQUESTING HON. DEOGRACIAS B. RAMOS, JR., REPRESENTATIVE, 2<sup>ND</sup> CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY ONE MILLION PESOS (P 51,000,000.00) FOR THE CONSTRUCTION OF SOLAR POWERED MULTI-PURPOSE BUILDING OF THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON

WHEREAS, the Municipality of Gubat has already conceptualized the importance of the construction of a multi-purpose building that will serve as a spacious facility designed and equipped to hold various public functions, activities and community services;

WHEREAS, it is significant for the Municipality of Gubat to have this multi-purpose building constructed to relieve the municipality from the burden of renting spacious place for hosting/conducting training and seminars, conventions and other community assembly;

WHEREAS, the construction of the said multi-purpose building will resolve the issue of the intermittent construction of smaller buildings in a limited space of the municipal compound all for the same purpose of having common facility to cater public functions and a number of public services;

WHEREAS, aside from the advantage of having one stop functional facility, the introduction of the solar powered provision of the building will in the future relieve the municipality from the burden of paying the high cost of electrical consumption which has taken considerable amount of municipal funds ever since;

WHEREAS, this municipality is looking forward to facilitate the construction of said solar powered multi-purpose building despite its requirement for huge amount of government funds, thus, the necessity of this local government unit to solicit financial assistance from the national government agency;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, earnestly requesting Hon. Deogracias B. Ramos, Jr., Representative, 2<sup>nd</sup> Congressional District, Province of Sorsogon, for financial assistance in the amount of Fifty One Million Pesos (P 51,000,000.00) for the construction of solar powered multi-purpose building of the Municipality of Gubat, Province of Sorsogon;

RESOLVED FURTHER, that copy of the Program of Works and Detailed Structural Plan of the multi-purpose building be attached to this resolution for reference and evaluation;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Hon. Deogracias B. Ramos, Jr., Representative, 2<sup>nd</sup> Congressional District, Province of Sorsogon, House of Representatives, Batasan Hills, Quezon City for favorable and appropriate action and all other concerned for information.
