RESOLUTION NO. 134 S - 2017

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), RO-V, REGARDING IMPLEMENTATION OF TULONG PANGKABUHAYAN SA ATING MGA DISADVANTAGED/DISPLACED (TUPAD) WORKERS PROGRAM IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, this local government unit will enter into Memorandum of Agreement with the Department of Labor and Employment (DOLE) with regards to the implementation of Tulong Pangakabuhayan sa ating Disadvantaged/Displaced (TUPAD) Workers Program aims towards providing assistance to the displaced workers, underemployed and seasonal workers to engage in short-term community works and to provide them with temporary wage employment for a certain period/days;

WHEREAS, the total cost of the project from the DOLE is P 2.5 million to be used exclusively for the implementation of the project in the municipality;

WHEREAS, the Local Government Unit of Gubat ensures the implementation of the project based on the approved project proposal and is capable of providing the equity or counterpart equivalent to 20% of the total project cost;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE), RO-V, regarding the implementation of DOLE Tulong Pangkabuhayan sa ating Disadvantaged/Displaced (TUPAD) Workers Program in the Municipality of Gubat, Sorsogon.
