WHEREAS, the municipality shall be responsible of the maintenance of the building and other required facilities including the honorarium of the volunteer Physical Therapist and staff;

RESOLVED, as it is hereby resolved to authorize Honorable Sharon Rose G. Escoto, municipal mayor to enter into a Memorandum of Agreement with the Cerebral Palsy Association of Sorsogon, Inc., regarding the use/management and occupancy of the MAREKAS Building;
