RESOLUTION NO. 144 S-2016

A RESOLUTION EARNESTLY REQUESTING HON. FRANCIS JOSEPH "CHIZ" ESCUDERO, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY NINE MILLION (P29,000,000.00) PESOS FOR THE CONCRETING OF FARM TO MARKET ROAD, FROM THE NATIONAL HIGHWAY TO BARANGAY CABIGUHAN, GUBAT, SORSOGON CONSISTING OF 5,187.3 LINEAR METERS.

WHEREAS, providing better farm-to-market roads would encourage and achieve better delivery of socio-economic services, commerce, trade and industry and a well-rounded community growth and development;

WHEREAS, the farm-to-market road from the national highway extending towards barangay Cabiguhan, Gubat, Sorsogon was already open yet unconcreted due to financial incapacity of this Local Government Unit, thus, said road during rainy season is often muddy and not passable to any motor vehicles;

WHEREAS, the residents of barangay Cabiguhan for several years faces great difficulties in transporting their goods and agricultural produced specially during rainy days due to the undesirable condition of this road;

WHEREAS, if the said farm-to-market road be concreted this will greatly help and/or relinquish these residents to their perennial problem of having inaccessible road which contributed much to the stagnant socio-economic growth and development of this community;

WHEREAS, this municipality is mandated under the law to undertake necessary action in the furtherance of the delivery of basic services and facilities to their inhabitants;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, earnestly requesting Hon. Francis Joseph "Chiz" Escudero, Senator, Republic of the Philippines, for financial assistance in the amount of Twenty Nine Million (P29,000,000.00) Pesos for the concreting of farm to market road, from the national highway to Barangay Cabiguhan, Gubat, Sorsogon consisting of 5,187.3 linear meters;

RESOLVED FURTHER, that copy of this resolution be furnished the Hon. Francis Joseph "Chiz" Escudero , Senator, Republic of the Philippines, GSIS Building, Pasay City for favorable and appropriate action, and all concerned for information and guidance.
