WHEREAS, the Local Government Unit of Gubat, Sorsogon is a recipient of the establishment of Organic Techno Demo and Training Farm in partnership with the Department of Agriculture;

WHEREAS, the project of the establishment of Organic Techno Demo Farm pertains to the provisions on the establishments of organic agriculture that will cumulatively condition and enrich the fertility of the soil, increase farm productivity; reduce pollution and destruction of the environment and protect the health of farmers, consumers and the general public.

WHEREAS, the implementation of the project requires this municipality to enter into MOA with the Department of Agriculture (DA) for the transfer of One Million and Five Hundred Thousand Pesos (Php. 1,500,000.00) as the total project cost;

WHEREAS, the municipality is capable of providing the 20% counterpart of the total project cost;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Valentin A. Pura IV and Hon. Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Agriculture, Regional Field Office No. V, with regards to the establishment of Organic Techno Demo and Training Farm in the Municipality of Gubat, Sorsogon;
