RESOLUTION NO. 149 S-2016

A RESOLUTION AUTHORIZING THE HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA), OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA) DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) AND WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) WITH REGARDS TO THE ESTABLISHMENT OF OFW HELP DESKS IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, this local government unit will enter into Memorandum of Agreement (MOA) with the agencies of DOLE for the convergence action pertaining to the strategy of empowerment and protection of the public and migrant workers specifically on welfare services, anti-illegal recruitment and anti-trafficking in persons, skills training, reintegration, and public information and education;

WHEREAS, the parties to this MOA will specifically agree to cooperate on 1). Capability building of LGU partners and local stakeholders; 2). Public information and worker education on overseas employment; 3). Establishment of OFW Help Desks; 4). Illegal Recruitment-Free Local Government Unit campaign; and 5). Data collection and management on OFW's and their families;

WHEREAS, this MOA is a pre-requisite for the implementation of the program in the municipality;
