A RESOLUTION APPROVING THE APPLICATIONS FOR MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOPs) IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, Chapter VIII, Article I, Section 10, of the same Code states that "No tricycle-for-hire or pedicab-for-hire either for passenger or for cargo or both, shall be operated in this municipality without a MTOP or POP from the Sanggunian Bayan and a corresponding permit from the Office of the Mayor under the Municipal Revenue Code";
