RESOLUTION NO. 151 S-2016

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FIRE PROTECTION (BFP) RELATIVE TO THE EFFECTIVE COLLECTION OF THE TWENTY PERCENT 20% SHARE IN THE FIRE CODE REVENUES AND ITS EFFICIENT ALLOCATION FOR THE IMPROVEMENT OF MUNICIPAL BFP FIRE STATION.

WHEREAS, the Bureau of Fire Protection (BFP), through DOF-DBM-DILG Joint Circular No. 2015-01 dated, February 12, 2015, is hereby authorized to release the 20% share in the Fire Code Revenues to concerned cities/municipalities for the period covering 2010-2013 which amount shall be directly released by the Department of Budget and Management (DBM) to the municipality;

WHEREAS, this local government unit undertakes to appropriate the twenty 20% share exclusively for the improvement and maintenance of the Municipal Bureau of Fire Protection Station to include acquisition of fire fighting equipment, service vehicles, investigative equipment, rescue equipment, office equipment, office furniture and fixtures and construction/repair of municipal BFP fire station;

WHEREAS, to ensure the effective collection of the amount, and for efficient allocation thereof, the necessity of this LGU to enter into MOA with the BFP is a prerequisite;

NOW THEREFORE, on motion of Hon. Valentin A. Pura and duly seconded by Hon. Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved, to authorize the Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Bureau of Fire Protection (BFP) relative to the effective collection of the twenty percent (20%) share in the Fire Code Revenues and its efficient allocation for the improvement of Municipal BFP Fire Station;

RESOLVED FURTHER, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, Mr. Reymundo F. Quinones, Municipal Treasurer, LGU-Gubat, Sorsogon, and SFO4 Jose T. Ebdane, Fire Marshall, BFP Municipal Fire Station, Gubat, Sorsogon, for appropriate action;
