RESOLUTION NO. 151 S-2017

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY (NHA) RELATIVE TO THE RELEASE OF TWELVE MILLION PESOS (PHP. 12,000,000.00) INTENDED FOR LAND DEVELOPMENT OF GUBAT RESETTLEMENT PROJECT AT SAN IGNACIO, GUBAT, SORSOGON UNDER THE RESETTLEMENT ASSISTANCE PROGRAM FOR LOCAL GOVERNMENT UNITS (RAP-LGU).

WHEREAS, the Municipality of Gubat has availed of the Resettlement Assistance Program for Local Government Units (RAP-LGU) of the National Housing Authority (NHA);

WHEREAS, this Local Government Unit has already complied with the requirements pertinent to the availment of the program particularly the purchase of land to be utilized as the site of the project;

WHEREAS, the project was already initially implemented out of the fund released by your agency in the amount of Six Million Pesos (Php 6,000,000.00) intended for the construction of core houses on the said resettlement project;

WHEREAS, the continuation of the project is of significant to the municipality to address the problem of relocating families occupying areas affected by the proposed construction of developmental projects of the municipality and the relocation of selected households situated on hazardous areas of costal and river banks;

NOW THEREFORE, on motion of Hon. John Paul E. Erlano. and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, authorizing Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the National Housing Authority (NHA) relative to the release of Twelve Million Pesos (Php. 12,000,000.00) intended for land development of San Ignacio Resettlement Project at San Ignacio, Gubat, Sorsogon under the Resettlement Assistance Program for Local Government Units (RAP-LGU);

RESOLVED FURTHER, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, Mr. Faustino Taclan, Jr., LGU-Gubat, Sorsogon and Hon. Marcelino P.
