A RESOLUTION ENDORSING TO THE NATIONAL HOUSING AUTHORITY (NHA) THE PROPOSED PROJECT FOR LAND DEVELOPMENT OF SAN IGNACIO RESETTLEMENT PROJECT, SAN IGNACIO, GUBAT, SORSOGON

WHEREAS, the Local Government Unit of Gubat has already availed of the Six Million Pesos (Php 6,000,000.00) fund from the National Housing Authority for the construction of Core Houses at San Ignacio Resettlement Project;

WHEREAS, the construction of core houses were already completed but still unoccupied due to lack of provisions on road worthiness, drainage and other miscellaneous works necessary for easy access and protection of the site;

WHEREAS, there is an immediate need for land development of said resettlement area to make the facility fully operational and accessible in preparation for the impending relocation of informal settlers from the Gubat National High School premises affected by the construction of senior high school building and of those families situated at hazardous areas from coastal and landslide pruned areas of the municipality;

NOW THEREFORE, on motion of Hon. John Paul E. Erlano and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, endorsing to the National Housing Authority (NHA) the proposed project for land development of San Ignacio Resettlement Project, San Ignacio, Gubat, Sorsogon;
