RESOLUTION NO. 162 S-2016

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOPI) IN THE MUNICIPALITY OF GUBAT OF NAPOLEON T. PURA, JR WITH CASE NUMBER 05-09-1950 FOR ONE YEAR STARTING OCTOBER 2016 AND RONABETH VELASCO WITH CASE NUMBER 05-09-1590 STARTING THIS MONTH OF OCTOBER UNTIL MARCH, 2017.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, Napoleon Pura, Jr., and Ronabeth Velasco had applied before this office for the suspension of their MTOPI for reason that his public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTO) in the Municipality of Napoleon T. Pura, Jr. for a period of one year starting October 2016 with case number 05-09-1950 and Ronabeth Velasco starting this month of October until March 2017;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting October 2016;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicant and others concerned for their information and guidance.
