RESOLUTION NO. 168 S-2017

A RESOLUTION ADOPTING THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) FOR CY 2017-2023 OF THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, the formulation of the Comprehensive Development Plan involved the participation of various stakeholders in the community in its various stages, from visioning, situational analysis and the development of policy responses and interventions to development challenges facing the municipality;

WHEREAS, this Comprehensive Development Plan represents the collective aspiration, needs and priorities of the locality and therefore enjoys broad-based support;

WHEREAS, it is the municipal governments' call to all its constituents, resource institutions and stakeholders, both in and out of the municipality, to be proactive partners in the municipality's continuing progress and sustainable development;

WHEREAS, Section 20 of RA 7160 or the Local Government Code of 1991, mandates LGUs to prepare a Comprehensive Land Use Plan (CLUP), and Sections 106 and 109 of the same code mandate LGUs to prepare comprehensive multi-sectoral development plans or Comprehensive Development Plan (CDP) and public investment programs;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to adopt the Comprehensive Development Plan for CY 2017-2023 of the Municipality of Gubat, Sorsogon;
