RESOLUTION NO. 170 S-2016

A RESOLUTION ENDORSING TO HON. LEONOR M. BRIONES, SECRETARY, DEPARTMENT OF EDUCATION, THE REQUEST OF VARIOUS ELEMENTARY SCHOOLS IN THE MUNICIPALITY OF GUBAT, SORSOGON FOR THE REPAIR AND CONSTRUCTION OF ADDITIONAL CLASSROOMS, SCHOOL BUILDINGs AND FACILITIES IN THEIR RESPECTIVE SCHOOLS

WHEREAS, Article II, Section 3 of the 1987 Philippine Constitution provides that “the state recognizes the vital role of the youth in nation-building, and shall promote and protect the their physical, moral, spiritual, intellectual and social-being”;

WHEREAS, the Local Government Unit of Gubat is envisioned to extend social services to its constituents by way of supporting the undertakings of educational institutions within the jurisdiction of the municipality;

WHEREAS, attached hereto is the consolidated request of different elementary schools within our jurisdiction looking forward to have the repair and construction of school buildings, additional classrooms and facilities in their respective schools;

WHEREAS, the construction of these school buildings, additional classrooms and facilities are necessary considering that the school population increases annually in unprecedented growth and school buildings can no longer accommodate and the realization of the said construction would be of great help in the delivery of basic and quality public service;

WHEREAS, this local government unit is more than aware of the urgent needs of these schools but considering the huge amount needed for the said constructions, such request remain unrealized, hence, the need to endorse the project to the national agency concern for possible and favorable action;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, endorsing to Hon. Leonor M. Briones, Secretary, Department of Education, the request of various elementary schools in the Municipality of Gubat, Sorsogon for the repair and construction of additional classrooms, school building and facilities in their respective schools;
