A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL OFFICE NO. V, FOR THE PURPOSE OF GAINING ACCESS TO THE DATABASE OF THE DEPARTMENT UNDER THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR).

WHEREAS, National Household Targeting System for Poverty Reduction (NHTS-PR) is a data bank and an information management system aimed to identifies who and where the poor are in this country. The collection of data is material on the identification of socio-economic status of the households needed for the implementation of Social Protection Programs of this municipality in partnership with the Department of Social Welfare and Development (DSWD);

WHEREAS, the use of this database will set the direction of the projects, programs and activities of this municipality on the concentrated areas with high incidence of poverty, uplifting the community economic sustainability and reducing poverty. The

system can also correlate other poverty related problems like human trafficking in order to prevent them from even happening to our locality;

WHEREAS, this municipality finds it important to have an access to this data base as basis of pertinent information in setting the direction of our local resources in addressing poverty issues.

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD), Regional Office No. V, for the purpose of gaining access to the database of the department under the National Household Targeting System for Poverty Reduction (NHTS-PR);
