RESOLUTION NO. 175 S-2017

A RESOLUTION RESPECTFULLY REQUESTING THE LAND TRANSPORTATION AND FRANCHISING REGULATORY BOARD (LTFRB) TO GRANT CERTIFICATE OF PUBLIC CONVENIENCE (CPC) FOR UV EXPRESS TO PLY THE GUBAT, SORSOGON - LEGASPI CITY ROUTE AND VICE VERSA TO ADDRESS THE NEED FOR ADDITIONAL PUBLIC CONVENIENCE VEHICLE IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Gubat-Legaspi Trans Drivers and Operators Association (GLTDOA) submitted to this Sangguniang Bayan their need for a supplementary public convenience vehicle to augment the necessity of public transport in this municipality and to provide better and prompt public service to the riding public;

WHEREAS, in order to effectively address and carry out this need for UV Express to ply the Gubat, Sorsogon - Legaspi City and vice versa, the association deemed it appropriate to request the herein Sangguniang Bayan to pass a resolution requesting the LTFRB to grant franchise for said UV Express route;

WHEREAS, this Sangguniang Bayan in response to the above-cited request and to ensure effective and efficient delivery of basic services and facilities, find it necessary to address their request with dispatch in order not to hamper the general welfare and interest of the riding public;

NOW THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, respectfully request the Land Transportation and Franchising Regulatory Board (LTFRB) to grant Certificate of Public Convenience (CPC) for UV Express to ply the Gubat, Sorsogon - Legaspi City and vice versa to address the need for additional public convenience vehicle in the Municipality of Gubat, Sorsogon;

RESOLVED FURTHER, that copy of this resolution be furnished Atty. Jun Abrazaldo, Regional Director, LTFRB Regional Office 5, Regional Center, Rawis, Legaspi City, 4500, for favorable action; and the President of GLTDOA, Gubat, Sorsogon, for their information and guidance.
