A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), PROVINCIAL GOVERNMENT OF SORSOGON AND WITH THE MUNICIPALITES OF PRIETO DIAZ, STA. MAGDALENA, MATNOG AND BULAN FOR THE FORMATION OF SORSOGON PACIFIC COAST INTER-LGU ALLIANCE ON ECOSYSTEMS APPROACH TO FISHERIES MANAGEMENT

WHEREAS, the Bureau of Fisheries and Aquatic Resources is mandated under the Fisheries Code to assist the local government units (LGUs) in developing their technical capability in the development, management, regulation, conservation of the fishery resources;

WHEREAS, one of the effective tools designed by the BFAR in achieving sustainable fisheries management compliant to ecosystem approach is the formation of Sorsogon Pacific Coast Inter-LGU Alliance participated by LGUs with coastal resources

in order to have a consolidated and/or coordinated efforts, services and resources in dealing with various subjects on fisheries management and development;

WHEREAS, this local government unit undertakes to actively participate in the cooperation and alliance with other LGUs in the management, conservation, development, protection, utilization and disposition of all fish and fishery/aquatic resources within the municipal waters in partnership with the Bureau of Fisheries and Aquatic Resources (BFAR);

WHEREAS, this partnership requires the local government unit to enter into Memorandum of Agreement (MOA) with the participating LGUs and with the Bureau of Fisheries and Aquatic Resources (BFAR);
