RESOLUTION NO. 176 S-2017

A RESOLUTION SUPPORTING THE CALL OF THE LOCAL CHIEF EXECUTIVE FOR A LOCALIZED PEACE TALKS AND CEASEFIRE BETWEEN THE AFP-PNP AND THE CPP/NPA/NDF IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, the Local Government Unit of Gubat, Sorsogon headed by Honorable Mayor Sharon Rose G. Escoto is calling for a localized peace talk and ceasefire between the Armed Forces of the Philippines (AFP)-Philippine National Police (PNP) and the Communist Party of the Philippines (CPP)/New People’s Army (NPA)/National Democratic Front (NDF) as an initiative to reach out and expand space for dialogue about building peace and resolving conflict;

WHEREAS, this endeavour of the local chief executive was initiated in response to the recently reported number of killings of civilians and PNP personnel during the past six (6) months which in effect put the municipality into a havoc situation causing alarm and fear to the residents;

WHEREAS, the local chief executive still adheres to the spirit of peace talks and/or collaboration and participation of every sectors for a practical solutions to resolve conflict;

WHEREAS, the Sanggunian Bayan is of common stand to consider also the possibility of installing peace negotiation from both parties as an avenue for building peace and resolving conflict to avoid further damage which in effect will confront this municipality into more difficult situation disadvantageous to the peace and order situation and general welfare of the municipality;

NOW THEREFORE, on motion of Hon. John Paul E. Erlano and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to support the call of the Local Chief Executive for a localized Peace Talks and Ceasefire between the AFP-PNP and the CPP/NPA/NDF in the Municipality of Gubat, Sorsogon;
