WHEREAS, these killings created fear and confusion to the residents of the municipality for reason that perpetrators are still unknown; and residents are anxious that maybe one of these days one of their family members might be the next victim;

WHEREAS, this local government unit is more than aware of the fear and distress suffered by the residents caused by this killings which the present administration is working hard to appease the situation;

WHEREAS, as mandated by law, the sangguniang bayan promotes the safety of its inhabitants, safeguard their human rights, and the maintain peace and order in this locality;

WHEREAS, similar incident should be abhorred in the strongest term possible considering that it is an apparent threat to the safety and security of our inhabitants and destroy the peace and tranquility of this town;

NOW THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to strongly condemn the killings in the Municipality of Gubat, Sorsogon;
